#### PARCEL I:

BLOCK I IN NORTHWES FERN UNIVERSITY SUBDIVISION, BEING A PART OF SECTION FAND IR TOWNSHIP II NORTH, RANGE 14, PAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED FERRUARY II NOW, AS DOCUMENTING, 1905, IN COOK COUNTY, ILLINOIS.

### PARCEL 2:

THAT PART OF LAKE MICHIGAN LYING EAST OF AND ADJOINING THOSE PORTIONS OF FRACTIONAL SECTION I AND SECTION IS, TOWNSHIP 41 RORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, OCCUPIED BY THE CAMPUS OF NORTHWESTERN UNIVERSITY AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:
