WILSON, husband and wife, and in consideration of Ten--(\$10.00)--Dollars, and other good and valuable considerations in hand paid, Convey(s) and Warrant(s) unto FIRST MIDWEST BANK, AS SUCCESSOR TO PALOS BANK AND TRUST COMPANY, an Illinois Banking Corporation of the United States

of America, as Trustee under the provisions of a Trust Agreement dated the 4th day of November, 2010 and known as Trust Number 9013 in the following described real estate in the County of Cook in the State of Illinois, to wit:

This conveyance is made upon the express understanding and condition that neither FIRST MIDWEST BANK, AS SUCCESSOR TO PALOS BANK AND TRUST COMPANY individually or as Trustee, nor its successors in Trust shall incur any personal liability or be subjected to any claim, judgement or decree for anything it or they or us or their agents or

attorneys may do or omit to do or about the said real estate or under the provisions of this Deed or said Trust Agreement or any amendment thereto or for injury to person or property happening in or about said real estate, any all such liability being hereby expressly waived and released. Any contract, obligations or indebtedness incurred or entered into by the Trustee in connection with said real estate may be entered into by it in the name of the then Beneficiary (ies) under Trust Agreement as their attorney-in-fact, hereby irrevocably appointed for such purposes, or at the election of the Trustee, in its own name, as Trustee of an express Trust and not individually (and the Trustee shall have no obligations whatsoever with respect to any such contract, obligation or indebtedness except only so far as the Trust property and funds in the actual possession of the Trustee shall be applicable for the payment and discharge thereof). All persons and corporations whomsoever and whatsoever shall be charged with notice of this condition from the date of the filing for record of this Deed.

Any the said Grantor(s) hereby expressly waive(s) and release(s) any and all right or benefit under and by virtue of any and all statutes of the State of Illinois providing for the exemption of homesteads from sale on execution or otherwise.
