

Section 3 for the Periodic Payment to Lender of the yearly premium installments for property insurance on the Property; and (ii) Borrower's obligation under Section 5 to maintain property insurar a coverage on the Property is deemed satisfied to the extent that the required coverage is provided by the Owners Association policy.

What cender requires as a condition of this waiver can change during the term of the
