I, the undersigned, do hereby certify that:

- 1. An Estate was opened for Jean B. Gibson, following her death on June 27, 2001, under Case No. 2001 P 8255.
- 2. At the time of her death, Jean B. Gibson was the owner of property commonly known as 6716 N. Seeley Avenue, Chicago, Illinois.
- 3. Under the Illino's Probate Act, the property was to be divided equally between Jean B. Gibson's children, Debra Simon, Gina McCartney, and John McCartney.
- 4. During the administration of the Estate of Jean B. Gibson, deceased, Gina McCartney lived on the property with her two sons, Sam McCartney and Michell Abdelkoui.
- 5. Gina McCartney died in 2008, and since that time, her two sons lived in the property without the permission of the estate, and they were asked to leave.
- 6. Sam McCartney ("McCartney") and Mitchell Abuelkoui ("Abdelkoui"), continued to live in the property to the detriment of the estate, and they cid not pay rent. An eviction matter was filed to evict them from the premises, in Case No. 2010 M1 1726092.
- 7. Two days before the Court hearing, McCartney and Abusinoui moved out. The locks were changed, and the boys were seen breaking back into the property causing damage to the property. Police were called, but declined to file a report unless the eye witness would come forward. Their personal property was removed and the place was boarded up at additional expense which was borne by the Administrator personally as there are no other assets in the estate.
- 8. Due to the damage caused, legal costs and fees incurred, McCartney and Abdelkoui wrongfully deprived the estate of proceeds from the sale of the property, as it is unsaleable in its present condition, and therefore, deprived the other heirs.
- 9. Accordingly, Debra Simon and John McCartney are entitled to payment a claim in the amount of Thirty-Two Thousand dollars (\$32,000) for legal fees and costs, unpaid rent, boarding up costs, and costs to change the locks of the subject property:
