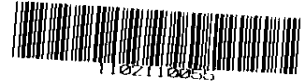

SUBORDINATION AGREEMENT


