- That this court has jurisdiction of the parties and the subject matter by virtue of the following:
 - a) On April 19, 2005 RORY O'CONOR filed a Voluntary Fetition for relief pursuant to Chapter 13 of the Bankruptcy Code (11 USC 101 et. seq.)(hereinafter called "THE CODE") in the Northern District of Illinois case number 05 B 15142;
