WHEREAS, the Declaration was subsequently amended by an Eighth Amendment To Declaration Of Condominium Ownership And Easements, Covenants and Restrictions For Renaissance Estates Condominiums dated July 20, 2009 and recorded on July 22, 2009 as document number 0920345077 in order to annex a certain portion of the Additional Parcel and to subject the same to the terms of the Declaration as well as the by-laws contained therein;

WHEREAS, the Declaration was subsequently amended by a Ninth Amendment To Declaration Of Condeminium Ownership And Easements, Covenants and Restrictions For Renaissance Estates Condeminiums dated November 11, 2009 and recorded on November 13, 2009 as document number 0/31718123 in order to annex a certain portion of the Additional Parcel and to subject the same to the terms of the Declaration as well as the by-laws contained therein;

WHEREAS, the real estate legally described on Exhibit B attached hereto ("Added Property") constitutes a further portion of the Additional Parcel;

WHEREAS, Declarant desires to annex the Added Property together with the improvements and other permanent fixtures located thereon to the Parcel and to subject the Added Property to the Declaration and the by-laws contained therein; and

WHEREAS, the Added Property is now improved with one (1) building containing a total of six (6) condominium units.

NOW THEREFORE, Declarant hereby declares that the Declaration be and hereby is amended as follows:

1. The Added Property set forth on Exhibit B attached hereto and incorporated herein by reference is hereby added-on and annexed to the Parcel and is hereby subjected to the provisions of the Declaration and submitted to the provisions of the Act. Accordingly, the legal description of the Parcel as set forth on Exhibit "A" of the Declaration is hereby amended to set forth the legal description of the Added Property as well as the legal description of those portions of the Additional Parcel previously annexed. Exhibit A attached hereto and incorporated herein

by reference shall be and serve as the amended Exhibit A to the Declaration.

- 2. The plat of survey attached to the Declaration as Exhibit "E" showing the boundaries of the Parcel and delineating and describing the Units contained therein is hereby further amended and supplemented according to Exhibit E attached hereto showing the boundaries of the Added Property and of the Parcel as amended and delineating and describing the additional Units contained in said Added Property.
- 3. Exhibit "C" attached to the Declaration setting forth the percentages of the undivided interests in the Common Elements appurtenant to each Unit described in Exhibit "A" of the Declaration are hereby reduced to the respective percentages set forth in Exhibit C attached hereto and incorporated herein by reference.
- 4. The factes and bounds legal description of the Parcel as set forth in paragraph 2 of the Declaration is hereby amended to include those portions of the Additional Parcel previously annexed thereto as well at the Added Property. Accordingly, the amended metes and bounds legal description of the Parcel as set forth in paragraph 2 of the Declaration shall be as set forth in Exhibit D attached hereto and incorporated herein by reference.
- 5. Exhibit "B" attached to and forming a part of the Declaration (describing the Additional Parcel) is hereby amended to except therefrom those portions of the Additional Parcel annexed to the Declaration by this Tenth Amendment as well as by all prior amendments thereto. Accordingly, such amended Exhibit "B" of the Declaration shall be as set forth on Exhibit F attached hereto and incorporated herein by reference.
- 6. The additional common elements added to the Declaration by this Tenth Amendment, are hereby granted and conveyed to the respective grantees of Units heretofore conveyed, all as set forth in the Declaration.
- 7. It is expressly understood and agreed that all dwellings and other improvements and permanent fixtures located on the Parcel as well as all owners of such dwellings and Renaissance Estates Condominium Association shall be subject to the terms and conditions set forth in that certain Redevelopment Agreement dated and recorded April 11, 2006 and entered into by and among the City of Chicago, JTA Development, Inc., Renaissance Estates Phase One L.P., LaSalle Bank N.A., as trustee under trust agreement dated November 6, 2001 and known as trust number 128423, and LaSalle Bank N.A., as trustee under trust agreement dated May 13, 2003 and known as trust number 131252.
- 8. Units 1505 and 1511 of the Added Property (i.e., Venetian-style 2<sup>nd</sup> floor units) must have carpeting as floor covering in the bedrooms and living room area of said Units. No hard surfaces may be used as floor covering in these areas of said Units.
- 9. Except as expressly set forth herein, the Declaration as previously amended shall remain in full force and effect in accordance with its terms.
