#### Claimant further states as follows:

- 1. On or about February 1, 2010, one or more of Owners owned fee simple or beneficial title to the real estate (including all land and improvements thereon) (the "Real Estate") in Cook County, Illinois, commonly known as 208 South LaSalle Street, Chicago, Illinois 60604 and legally described as on the attached Exhibit A.
- 2. Sometime prior to February 1, 2010, one or more of Owners entered into a general construction contract with ICM to construct improvements on the Real Estate. By Agreement dated February 1, 2010, ICM subcontracted with R.G. for R.G. to provide all drywall and related materials, equipment and labor relating to the stairwell reconfiguration project as described in the Subcontract for the improvement of the Real Estate all in exchange for payment (collectively, the "R. G. Subcontract").
- 3. The R. G. Subcontract was entered into and the work was performed by R. G. with the knowledge and consent of Owners. Alternatively, Owner(s) specifically authorized ICM to enter into contracts for design and improvement of the Real Estate. Alternatively, Owners knowingly permitted ICM to enter into contracts for the design and improvement of the Real Estate.
- As to all lots comprising the Real Estate, R.G. last performed work on the Real Estate on or after October 17, 2010. Claimant does not believe that it is required to allocate or apportion its lien among any lots or parcels comprising the Real Estate because this lien is timely as to all lots comprising the Real Estate, nor does R.G. believe that allocation or apportionment among lots or parcels is possible or reasonably calculable because R.G.'s work was in, on, around and for the benefit of all lots and parcels.
- As of the date hereof, after all previous credits and payments there remains due, unpaid and owing to R. G. the principal balance of Seventy Eight Thousand Nine Hundred Twenty One Dollars and Zero Cents (\$78,921.00) for which, with interest, attorneys' fees and costs as provided under the Illinois Mechanics Lien Act, R. G. claims a lien on the Real Estate and on the monies or other consideration due or to become due from Owners to ICM, Inc.
