WHEREAS, a Declaration of Condominium Gwnership was entered into on March 30, 2007, and recorded in the office of the Recorder of Deeds of Cook County, Illinois, on May 22, 2007, as Document No. 0714215000, as amended by the First Amendment to Declaration of Condominium Ownership and recorded by the Recorde, of Deeds of Cook County, Illinois, on July 17, 2007, as Document No. 0719815059, and further amonded by the Second Amendment to the Declaration of Condominium Ownership and recorded by the Recorder of Deeds of Cook County, Illinois, on September 5, 2007, as Document No. 07242 6037 (together, hereinafter referred to as the "Declaration"); and

WHEREAS, each Unit's percentage of ownership interest in the common elements is set forth in Exhibit B attached to the Declaration;

WHEREAS, the Board and Unit Owners desire to amend the Declaration of Condominium Ownership to modify the existing percentage of ownership interest in the common elements; and

WHEREAS, this Amendment has been approved and consented to in writing by the Board and by the requisite Unit Owners in compliance with the Declaration of Condominium Ownership, and any amendments thereto; and

WHEREAS, Exhibits A, B, and C attached hereto shall be incorporated herein and made a part of this Amendment; and

- 3. The recording of this Amendment shall alter or affect the amount of any lien for Common Expenses due from the owners of an existing Unit Ownership prior to such recording, and the respective amounts assessed to or due from the Unit Owner(s) of existing Unity for Common Expenses or other assessments levied prior to such recording.
- 4. Except as otherwise modified, altered and/or amended by this Amendment, the Declaration is declared to be, and shall continue in full force and effect, in accordance with its terms.
