MODIFICATION OF MORTGAGE

MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:


The Maturity Date of the Note is extended to April 1, 2011. All other terms and conditions remain as stated in the previous Change in Terms Agreement.



This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

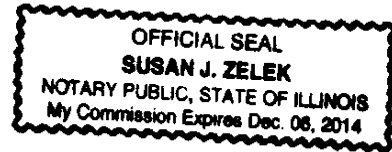
