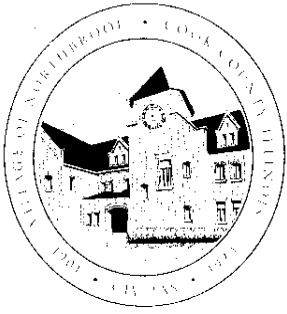

Property Description

THE NORTH 100 FEET OF THE SOUTH 200 FEET, MEASURED AT RIGHT ANGLES TO THE SOUTH LINE THEREOF OF THAT PART OF THE SOUTHWEST QUARTER OF SECTION 7, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN DESCRIBED AS FOLLOWS: COMMENCING AT THE INTERSECTION OF WALTERS AVENUE AND SANDERS ROAD CENTER LINES; THENCE SOUTHERLY ALONG THE CENTER LINE OF SAID SANDERS ROAD A DISTANCE OF 334.56 FEET TO THE POINT OF BEGINNING; THENCE WESTERLY ALONG A LINE PARALLEL TO SAID WALTERS AVENUE A DISTANCE OF 315.53 FEET TO A POINT, SAID POINT BEING THE NORTHEAST CORNER OF LOT 8 IN WOODOAKS COURT SUBDIVISION; THENCE SOUTHERLY ALONG THE EAST LINE OF LOT 8 A DISTANCE OF 100.62 FEET TO A POINT; THENCE EASTERLY ALONG A LINE PARALLEL TO SAID WALTERS AVENUE A DISTANCE OF 316.31 FEET TO THE CENTER LINE OF SANDERS ROAD; THENCE NORTHERLY A DISTANCE OF 100.67 FEET TO THE POINT OF BEGINNING, EXCEPT THE PORTION USED FOR ROADWAY PURPOSES, ALL IN COOK COUNTY, ILLINOIS.
