DEFAULT JUDGMENT ORDER

THIS CAUSE COMING ON TO BE HEARD on motion of Plaintiff, WESTERN HERITAGE INSURANCE COMPANY ("Plaintiff" or "Western Heritage"), for entry of default judgment in its favor and against Defendant, STEPHANIE A. SCHWARTZEL ("Schwartzel"), on the grounds that Schwartzel has failed to appear and/or answer or otherwise plead despite service of Summons and Amended Complaint and the Court being otherwise duly advised in the premises:

IT IS HEREBY ORDERED that:

- A. Schwartzel is held in default for failure to appear, answer or otherwise plead.
- B. Judgment is entered in favor of Plaintiff, Western Heritage Insurance Company, and against Defendant, Schwartzel, on Counts I and II of the Amended Complaint in the amount of NINETY-ONE THOUSAND, TWO HUNDRED TWENTY-EIGHT and 80/100ths (\$91,228.80) dollars plus court costs.
- C. On Count III of the Amended Complaint, this Court finds the judgment entered on Counts I and II of the Amended Complaint was not discharged by Schwartzel's bankruptcy filing pursuant to 11 U.S.C. §523(a)(4), §523(a)(6) and §523(c)(1) due to her failure to give Western
