CONTRACTOR'S MECHANIC'S LIEN -- NOTICE AND CLAIM

- 3. On or about December 3, 2010, Claimant completed all of the Work unue; true terms of and in accordance with the Contract, in that Claimant supplied all labor and materials necessary for perio mance of its duties under the Contract and for the additional improvements to the Property performed at the request an Unsistence of the Owner.
- 4. All of the labor and materials furnished and delivered by Claimant were furnished to and used in connection with the improvement of the Property, and the last of such labor and materials was furnished, delivered and performed, and the Work completed, on or about December 3, 2010.
- 5. After allowing to the Owners all credits, deductions and offsets, there is now justly due and owing the Claimant, for the Work, the sum of One Hundred and Ten Thousand One Hundred Thirty-Two and 00/100 Dollars (\$110,132.00) plus interest at the rate specified in the Illinois Mechanics Lien Act.
- 6. Claimant now claims a lien on the above-described Property, and on all of the improvements thereon, against the Owners and all persons interested therein, for One Hundred Ten Thousand One Hundred Thirty-Two and 00/100 Dollars (\$110,132.00) plus interest at the rate specified in the Illinois Mechanics Lien Act as well as court costs and attorney fees.
