- 4. Claimant completed its work under its contract on 9/7/2010, which entailed LABOR AND MATERIALS-REPLACEMENT OF 200F ON RESIDENCE AND GARAGE-SIDING. INSURANCE WORK to said premises.
- 5. There is due, unpaid and owing to Claimant, after allowing all credits, the principal sum of (\$2,337.02) which principal amount bears interest at the statutory rate of ten percent (10%) per annum, (as provided for by 770 ILCS 60/1) and costs and reasonable attorney fees (as provided for by 770 ILCS 50/17).
