### SUBORDINATION AGREEMENT

NOTICE:

THIS SUBOTRINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY DECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT

OTHER OR LATEK SECURITY INSTRUMENT.

THIS AGREEMENT, made this 22 dry of DECEMBER 2010by SAM D PINDRIK and SOFIA PINDRIK, owner of the land hereinafter described and holder of the mortgage deed and note first hereinafter described and hereinafter referred to as "Beneficiary";

WHEREAS, Owner has executed, or is about to execute, a mortgage deed and note in the sum of \$ 312,000. in favor of INTERBANK MORTGAGE COMPANY ISAOA/ATIMA, hereinafter reight to as "Lender," payable with interest and upon the terms and conditions described therein, which mortgage deed is to be reconded concurrently herewith; and

WHEREAS, it is a condition precedent to obtaining said loan that said mortgag: deed last above mentioned shall unconditionally be and remain at all times a lien or charge upon the land hereinbefore described, prior and superior to the lien or charge of the mortgage deed first above mentioned; and

WHEREAS, Lender is willing to make said loan provided the mortgage deed securing the same is a licen or charge upon the above described property prior and superior to the lien or charge of the mortgage deed first above mentioned and provided that Beneficiary will specifically and unconditionally subordinate the lien or charge of the mortgage deed first above mentioned to the lien or charge of the mortgage deed in favor of Lender; and

WHEREAS, it is to the mutual benefit of the parties hereto that Lender make such loan to Owner; and Beneficiary is willing that the mortgage deed securing the same shall, when recorded, constitute a lien or charge upon said land which is unconditionally prior and superior to the lien or charge of the mortgage deed fist above mentioned.

(continuation of Subordination Agreement between SAM D PINDRIK, SOFIA PINDRIK and THIRD FEDERAL SAVINGS AND LOAN ASSOCIATION OF CLEVELAND)

NOW, THEREFORE, in consideration of the mutual benefits accruing to the parties hereto and other valuable consideration, the receipt and sufficiency of which consideration is hereby acknowledged, and in order to induce Lender to make the loan above referred to, it is hereby declared, understood and agreed as follows:

- (1) That said mortgage deed securing said note in favor of Lender, and any renewals or extensions thereof, shall unconditionally be and remain at all times a lien or charge on the property therein described, prior and superior to the lien or charge of the mortgage deed first above mentioned.
- (2) That Lender would not make its loan above described without this subordination agreement.
- (3) That this agreement shall be the whole and only agreement with regard to the subordination of the lien or charge of the mortgage deed first above mentioned to the lien or charge of the mortgage deed in favor of Lender above referred to and shall supersede and cancel, but only insofar as would affect the priority between the deeds of trust hereinbefore specifically described, any prior agreement as to such subordination including, but not limited to, those provisions, if any, contained in the mortgage deed first above mentioned. Which provide for the subordination of the lien or charge thereof to another mortgage or mortgages.

Beneficiary declares, agrees and acknowledges that

- (a) He consents to and approves (I) all provisions of the note and mortgage deed in favor of Lender above referred to, and (ii) all agreements, including but not limited to any loan or escrow agreements, between Owner and Lender for the disbursement of the proceeds of Lender's loan;
- (b) Lender in making disbursement, pursuant to any such agreement is under no obligation or duty to, nor has Lender represented that it will, see to the application of such proceeds by the person or persons to whom Lender disburses such proceeds and any application or use of such proceeds for purposes other than those provided for in such agreement or agreements shall not defeat the subordination herein made in whole or in part;
- He intentionally and unconditionally waives relinquishes and subordinates the lien or charge of the mortgage deed first above mentioned in favor of the lien or charge upon said land of the mortgage deed in favor of Lender above referred to and understands that in reliance upon, and in consideration of, this waiver, relinquishment and subordination specific loans and advances are being and will be made and, as part and parcel thereof, specific monet ry and other obligations are being and will be entered into which would not be made or entered into but for said reliance upon this waiver, relinquishment and subordination; and
- (d) An endorsement has been placed upon the note secured by the rnortgage deed fist above mentioned that said mortgage deed has by this instrument been subordinated to the lien or charge of the mortgage deed in favor of Lender above referred to.
