WHEREAS, the Association administers the property as set forth and described in the Declaration and By-Laws of The Wil-Shore Condominium Association, an Illinois not-for-profit corporation, as amended from time to time; and

WHEREAS, pursuant to Paragraph 22 of the Declaration (as modified by applicable provisions of the Act), provisions in the Declaration relating to the use of the Common Elements may be changed, modified or rescinded by an instrument in writing setting forth such change, modification or rescission signed and acknowledged by Unit Owners owning not less than 75% of the total ownership of the common elements and containing an affidavit by the Secretary of the Board certifying that notification of the change, modification or rescission has been mailed by certified mail to all lien holders of record; and

WHEREAS, this Fourth Amendment has been signed and acknowledged by Unit Owners owning not less than 75% of the total ownership of the common elements and contains an affidavit by the Secretary of the Board certifying that notification of the change, modification or rescission has been mailed by certified mail to all lien holders of record.

NOW, THEREFORE, the Association hereby declares that the Declaration be and hereby is amended as follows:

Paragraph 8 shall be deleted in its entirety and replaced with the following:

- 8. (a) Use of the Common Elements. Each Unit Owner shall have the right to use the Common Elements (except the Limited Common Elements and portions of the building occupied pursuant to leases made by or assigned to the Board of Managers) in common with all other Unit Owners as heav be required for the purposes of access and ingress and egress to and use and occupancy and enjoyment of the respective Unit owned by such Unit Owner. Such right to use the Common Elements shall extend to each Unit Owner and the agents, servants, tenants, family members and invitees of each Unit Owner. Each Unit shall have the right to the exclusive use and possession of the Limited Common Elements contiguous to and serving such Unit alone or with adjoining Units. Such rights to use and possess the Common Elements (including the Limited Common Elements) shall be subject to and governed by the provisions of the Act and of this Declaration and the By-Laws and by the rules and regulations of the Association adopted by the Board from time to time which are not inconsistent with the provisions of this Paragraph 8.
- (b) Patios. The patios which respectively are contiguous to Units 101, 103 and 104 specifically are designated as Limited Common Elements assigned respectively to each of those units for the exclusive use and enjoyment of those

specific Unit Owners or their guests or invitees. This right to use shall not extend beyond the dimensions of the patios as they existed on November 1, 2010.

- (c) Use of the Sideyards. The landscaped sideyards located adjacent to the building shall not be subject to or available for general access by the Unit Owners or their guests or invitees. Those areas shall be kept and maintained by the Association as open areas for aesthetic purposes only; provided, however, that the Board may establish an area in the west portion of the sideyard situated along the south side of the building for a small park to be used for limited casual or recreational use by the Unit Owners or their guests and invitees as may be allowed by resolutions or rules and regulations adopted by the Board from time to time.
- (d) Concessions. The Association shall have the authority to lease or to grant concessions with respect to parts of the Common Elements subject to the provisions of the Declaration and By-Laws including specifically (but not be way of limitation) for the laundry. All income derived by the Association from leases, concessions or other such sources shall be held and used for the benefit of the Unit Owners pursuant to such policy resolutions or rules and regulations as the Board may adopt from time to time.

This Fourth Amendment shall become effective upon recording in the office of the Cook County Recorder of Deeds. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
