LEGAL DESCRIPTION

THAT PART OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 13, TOWNSHIP 42 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS: BEGINNING AT THE INTERSECTION OF THE SOUTH LINE OF THE NORTH 528.0 FEET OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 13, WITH THE CENTER LINE OF HAPP ROAD; THENCE NORTH WESTERLY ALONG SAID CENTER LINE 140.0 FEET TO THE PLACE OF BEGINNING OF THE TRACT OF AND HEREIN DESCRIBED; THENCE NORTH EASTERLY AT RIGHT ANGLES TO SAID CENTER LINE, A DISTANCE OF 143.90 FEET TO THE EAST LINE OF SAID NORTH EAST QUARTER OF THE SOUTHWEST QUARTER; THENCE NORTH ALONG SAID EAST LINE, A DISTANCE OF 127.25 FEET; THENCE SOUTH WESTERLY AT RIGHT ANLES TO THE CENTER LINE OF HAPP ROAD 202.42 FEET TO THE CENTER LINE OF HAPP ROAD; THENCE SOUTH EASTERLY ALONG SAID CENTER LINE 113.0 FEET TO THE PLACE OF BEGINNING IN COOK COUNTY, ILLINOIS.
