DECLARATION AMENDMENT

The Association of 4145 S. Wahash Condominium Association, by resolution of the unit owners comprising of a majority who attended a meeting on January 5, 2011. hereby records the following amendment to the Declaration, Document # 0620731071:

Rental of Units. "Rental" shall be defined as any Unit being occupied without an occupant that is on the deed for the property and without any occupant with a recorded ownership right to the Unit. No Unit may be used as a rental Unit. All units must be occupied by at least one owner, with a recorded interest in the property.

If any unit is found to be used as a rental, the Board, at its sole discretion may provide a 30 day notice to terminate tenancy. If the Unit Owner does not comply with the Board's request, the Board may proceed with an action in Chancery, or any other court of competent jurisdiction, to terminate the ownership rights by requesting an order of judicial sale.

Nothing in this Section shall be construed to limit the Board's right to rent a Unit for the purposes of recovery of past due assessments pursuant to the Illinois Condominium Property Act.

The legal description for the property is as follows:
