2. Judgment is hereby entered in favor of the Plaintiff, Yellow Book Sales and Distribution Company, Inc., a corporation, and against the Defendants, Awning Express, Inc., an Illinois corporation and Javier Ortega, in the amount of \$7,626.98, plus costs.

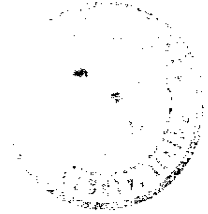
