#### MEMORANDUM OF CONTRACT

This Memorandum of Contract (this "Memorandum") is dated as of the 25th day of March, 2011.

#### WITNESSETH

- 1. Chicago Title Land Trust Company, not personally but as Trustee, under trust agreement dated July 24, 2009, and known as Trust No. 8002353453 ("Seller") owns a certain parcel of land located at 2333 W. Jackson Boulevard in Chicago, Cook County, Illinois, as more particularly described or shown in Exhibit A attached hereto and made a part hereof, together with all buildings, improvements, structures and fixtures located thereon (the "Property").
- 2. Seller has agreed to sell and TCB St. Stephens Limited Partnership, an Illinois limited partnership ("Purchaser") has agreed to purchase all of the Property all on the terms and conditions set forth in that certain Purchase and Sale Contract dated March 25, 2011 (the "Purchase Contract"), including the payment of a purchase price of \$12,800,000 ("Purchase Price"), and an option fee in an amount of \$500,000 (the "Option Fee").
- 3. The Purchase Contract provides that Purchaser must acquire the Property subject to certain contingencies, by October 15, 2011, subject to extensions.
- 4. The Purchase Contract provides that (i) if certain contingencies are not met and Purchaser notifies Seller in writing that such contingencies have not been met, then (a) Seller shall return the Option Fee, (b) the Purchase Contract shall be terminated and (c) the parties hereto shall have no further rights, obligations or liabilities hereunder; (ii) if all of the contingencies are met and Purchaser fails to acquire the Property by the Closing Date, then (a) Seller shall retain the Option Fee, (b) the Purchase Contract shall become null and void and (c) the parties hereto shall have no further rights, obligations or liabilities hereunder.
