The Mortgage secures the indebtedness, obligations and liabilities of Mortgagor prisuality to a promissory note in the original principal amount of Five Hundred Thousand and and 00/100 Dollars (\$500.00.00), payable to Mortgagee and executed jointly and severally by Mortgagor and modified by that certain First Modification Agreement dated December 10, 2006 (the "First Note Modification") and modified by that certain Second Modification Agreement dated March 10, 2007 (the "Second Note Modification") which among other things increased the credit line availability of the Note to \$800,000.00 payable to Mortgagee and executed jointly and severally by Mortgagor and modified by that certain Third Modification Agreement dated March 10, 2009 (the "Third Note Modification") ("Note").
- 3. The principal balance of the Note is due and payable on March 10, 2011. As of the date hereof, the outstanding principal balance due is \$122,239.39.
- 4. Mortgagor wishes to amend the terms of the Note and the Mortgage, and Mortgagee is willing to do so.
