



and against loss by fire, hazards included within the term "extended coverage." and any other hazards, including, but not limited to, earthquakes and floods, from which Lender requires insurance, then: (i) Lender vaiv as the provision in Section 3 for the Periodic Payment to Lender of the yearly premium installments for provinty insurance on the Property; and (ii) Borrower's obligation under Section 5 to maintain property insurance coverage on the Property is deemed satisfied to the extent that the required coverage is provided by the Cavars Association policy.

What I ender requires as a condition of this waiver can change during the term of the loan.

Borrows shall give Lender prompt notice of any lapse in required property insurance coverage

provided by the master or blanket policy.
