2. On information and belief, said Owner contracted with Claimant for certain improvements to said premises.

3. Owner entered into a **written contract** with Claimant on **5/18/2010**.

4. Claimant completed its work under its contract on **4/19/2011**, which entailed **Labor-Professional Services to coordinate all required building approvals and code consulting** to said premises.

5. There is due, unpaid and owing to Claimant, after allowing all credits, the principal sum of **(\$37,783.00)** which principal amount bears interest at the statutory rate of ten percent (10%) per annum, (as provided for by 770 ILCS 60/1) and costs and reasonable attorney fees (as provided for by 770 ILCS 60/17).
