1. I, **GEORGE BIELOSZABSKI**, of (address) _____, appoint my attorney, **RENEE NORGLER** or **JOHN O'LEARY**, as my Attorney-In-Fact (my "agent") to act for me and in my name (in any way I could act in person) with respect to the following powers, as defined in Section 3-4 of the "Statutory Short Form Power of Attorney for Property Law" (including all amendments), but subject to any limitations on or additions to the specified powers inserted in Paragraph 2 or 3 below:

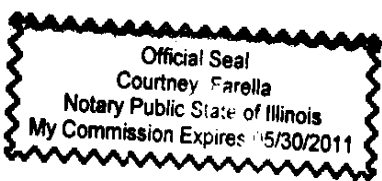
