Commonly known as: 111 North Wabach Avenue, Chicago, Illinois 60602 (the "Building")

was submitted to the provisions of the Illinois Concorninium Property Act (the "Act").

- B. This amendment is adopted pursuant to Section 26 of the Illinois Condominium Property Act (the "Act"). Said provisions provide that this amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, provided the same is executed by the parties to the transfer of a limited common element and by all other unit owners who have any right to use the limited common element.
- C. Transfer of limited common element Storage Space L.C.E. 1413:
 - 1. The Declarant is the legal owner of limited common element Storage Space L.C.E. 1413. The Declarant has not yet assigned limited common element Storage Space L.C.E. 1413 to any Unit in the Association.
 - 2. Caris is the legal owner of Unit 1501.
 - 3. Declarant is desirous of assigning limited common element Storage Space L.C.E. 1413 to be appurtenant to Unit 1501 owned by Caris, and Caris is desirous of affecting such assignment.
 - 4. Such a transfer is permitted pursuant to Section 26 of the Act and Section 3.4 of the Declaration.
 - 5. Such a transfer will not change or affect the parties' respective percentage interest in the Common Elements for the Units owned by the parties.

- The above recitals are incorporated into this Amendment. 1.
- Pursuant to Section 26 of the Act and Section 3.4 of the Declaration, the undersigned consent and 2. agree that the Declaration is hereby amended to provide that all right, title and interest in and to Storage Space L.C.E. 1413, a limited common element, is hereby assigned to Caris and made appurtenant to Unit 1501 owned by Caris.
