The original Promissory Note dated November 30, 1998 with a maturity date of December 1, 2003 in the original amount of \$265,000.00 to Family Bank and Trust Company which was modified September 1, 2004 to extend the maturity date to September 1, 2009 and change the interest rate to 7.80% and to change the amortization to conform to a 171 month amortization, which was further modified to extend the maturity to December 1, 2009, which was further modified to extend the maturity to June 1, 2010, which was further modified to extend the maturity to December 1, 2010 and to change the Note to a 102 month amortization with monthly principal and interest payments \$2,229.09; which was further modified to extend the maturity to March 1, 2011 and to change the Note to a 96 month amortization with monthly principal and interest payments of \$2,231.57 and is now being modified to change the Note to a 93 month amortization with monthly principal and interest payments of \$2,111.73 and to extend the maturity to August 1, 2011.
