IT IS HEREBY ORDERED THAT, for the reasons stated on the record, judgment is entered in favor of the Plaintiff and against Defendant Lakeshore Motorcars, Inc. on Counts 1-4 in the amount of \$1,290,750 and Counts 5-8 in the additional amount of \$517,544. As of the date hereof, the Plaintiff shall be deemed to have already recovered on account of this judgment for purposes of the "single satisfaction" rule under section 550(d) of the Bankruptcy Code, a total of \$126,220 from the sale of the following vehicles: (1) a 2010 Cadillac SRX for \$33,000, (2) a 2009 Cadillac Escalade Hybrid for \$46,800, (3) a 2000 Lexus GS 350 for \$23,755, and (4) a 2010 Toyota Rav 4 for \$22,665.
