EXHIBIT A

DESCRIPTION OF COLLATERAL

Capitalized terms not defined herein shall have the meanings ascribed to them in that certain Mortgage, Security Agreement, and Fixture Filing dated as of May 5, 2011 by Debtor, as Mortgagor, and Secured Party, as Lender.

Debtor does hereby mortgage, give, grant, bargain, sell, alien, enfeoff, convey, confirm, pledge, assign and hypothecate unto Secured Party, its survivor and other successor or successors, WITH MORTGAGE COVEN ANTS, and with the power of sale and right of entry, a first priority lien in all of Debtor's estate, right, title and interest in, to and under any and all of the following described property (the "Security Property"), whether real or personal, tangible or intangible, now owned or held or hereafter acquired:

- (a) the Premises (as further described in Exhibit B attached hereto);
- (b) the Improvements;
- (c) the Chattels;
- (d) all Deposit Accounts, Letter of Credit Rights, Commercial Tort Claims, Supporting Obligations, Investment Property, Security Excitlements, General Intangibles and Equipment (as all of such terms are defined in the UCC) related to the Debtor;
- (e) all proceeds of the conversion, voluntary or involuntary, of any of the foregoing into cash or liquidated claims, including, without limitation, proceeds of insurance and condemnation awards and any unearned premiums accrued, accruing or w accrue under any and all insurance policies now or hereafter obtained by Debtor and real estate tax and assessment refunds and credits at any time accruing to the benefit of Debtor or the Security Property, even if relating to taxes and assessments payable for a period or periods prior to the date hereof;
- (f) all leases of the Premises or any part thereof now or hereafter entered into and all right, title and interest of Debtor thereunder; and including, without limitation, Debtor's right, if any, to cash or securities deposited thereunder, whether or not same was deposited to secure performance by the lessees of their obligations thereunder, including, further, the right upon the happening of an Event of Default, to receive and collect the rents and other charges thereunder;
- (g) all utility or municipal deposits made by or on behalf of Debtor or made in connection with the Premises;
- (h) all plans, drawings, specifications, site plans, sketches, samples, contracts and agreements, however characterized from time to time, prepared for use in connection with the

construction, repair, renovation or maintenance of the Improvements, including all of Debtor's right, title and interest in, to and/or under the Plans and Specifications;

- (i) all contracts, agreements and understandings now or hereafter entered into, relating to or involving the performance of any work, rendering of any services, supply of any materials or the conduct of operations in and the management of the Premises, including, without limitation, construction contracts, architect agreements, management agreements, options and other agreements, however characterized, affecting the Premises and/or Improvements;
- (j) any and all permits, certificates, approvals and authorizations, however characterized ssued or in any way furnished, whether necessary or not, for the operation and use of the Premises and/or the Improvements and/or Chattels, including, without limitation, building permits, environmental certificates, certificates of operation, warranties and guarantees; and
