IT IS HEREBY ORDERED THAT for the reasons stated on the record, judgment is entered in favor of the Plaintiff and against Defendant Lakeshore Motorcars, Inc. on Counts 1-4 in the amount of \$1 290,750 and Counts 5-8 in the additional amount of \$517,544.
