NOTICE OF LIEN FOR UNPAID COMMON CHARGES

To: The Recording Officer of Cook County, Illinois; Leslee Danley; and whom else it may concern:

Please take notice that the Atrium Court Village Home Condominiums, an Illinois not-for-profit corporation, the undersigned Lienor, has and claims a lien for unpaid common elements charges pursuant to 765 Illinois Compiled Statutes 605/9, and pursuant to the Declaration of the Association, as follows:

- 1. The name of the lienor is the Atrium Court Village Home Condominiums, acting on behalf of all unit owners in the condominium association pursuant to a Declaration of Condominium, called the declaration and recorded as Document Number 86285253.
