EXHIBIT A TO UCC FINANCING STATEMENT

Debtor: SHEFFIELD-DIVERSEY, L.L.C.

Secured Party: THE NORTHERN TRUST COMPANY

Debtor has granted to Secured Party a security interest in the property owned by Debtor and described as follows:
