## ORDER OF DISMISSAL

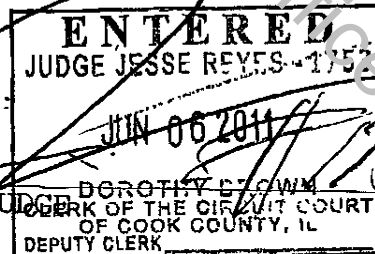
The above cause coming on to be heard on Motion of the Plaintiff, and the Court being advised in the premises;
