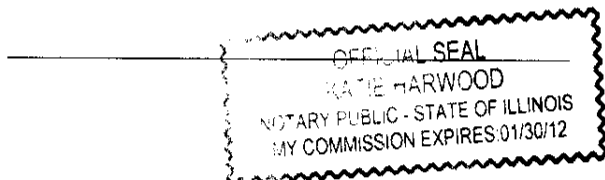

PERMITTED EXCEPTIONS
