## EXHIBIT A TO UCC FINANCING STATEMENT

- A. That certain real estate and improvements commonly known as Woodglen located at First Street, Lemont, Cook County, Illinois and legally described as on Exhibit B attached hereto and made a part hereof (collectively, the "Real Estate").
- B. All buildings and improvements of every kind and description heretofore or hereafter erected or placed on the Real Estate and all fixtures, apparatus and fittings of every kind and nature whatsoever now or hereafter attached to such Real Estate and the buildings and improvements now or hereafter located thereon and the operation, maintenance and protection thereof (the "Improvements"), and all renewals or replacements thereof or articles in substitution therefor, whether or not the same are or shall be attached to such Real Estate, buildings or improvements in any manner; it being mutually agreed, intended and declared that all the aforesaid property shall so far as permitted by law, be deemed to form a part and parcel of the Real Estate and for the purpose of this instrument to be real estate and covered by this instrument; and as to the balance of the property aforesaid, this instrument is hereby deemed to be as well a Security Agreement under the provisions of the Uniform Commercial Code for the purpose of creating hereby a security interest in such property, which is hereby granted by each debtor to secured party securing the interestedness hereby secured;
