The claimant, Environmental Systems Design, Inc. ("Claimant"), with an address at 175 West Jackson Blvd., Suite 1400, Chicago, Illinois 60604, hereby serves and files its Subcontractor's Notice and Claim for Mechanics Lien on the Real Estate (as hereinafter described), on the leasehold (as hereinafter described), and on all funds held in connection with the improvements constructed on the Real Estate and against UST Prime III Hotel Owner, L.P., ("Owner"), UST Prime III Hotel Subtenant, L.P., and 151 W. Adams Master Tenant LLC (collectively "Lessees"), Marriott Hotel Services, Inc. as hotel manager and owner's agent, The Union Labor Life Insurance Company on Behalf of Account J, Capri Urban Investors Reit Business (collectively "Lenders"), and Lucien Lagrange Architects, Ltd. ("Architect"), and against the interest of any person claiming an interest in the Real Estate (as hereinafter described) by, through or under Owner or Lessees.

Claimant states as follows:

1. At all times relevant, and as of March 5, 2008 and subsequent thereto, Owner owned fee simple title to the real estate, including all land and improvements thereon (the "Real Estate"), in Cook County, Illinois, commonly known as 208 South LaSalle Street, Chicago, Illinois and legally described as follows:

2. On information and belief, on or about March 6, 2009 and subsequent thereto, the Lessees were Owner's lessees pursuant to leases for the Real Estate.

3. On information and belief, Owner and Architect entered into an agreement effective November 17, 2006, pursuant to which Architect was to provide architectural/engineering design services for the development of hotel space on the Real Estate.

4. Architect made a written contract with Claimant effective February 9, 2007, under which Claimant agreed to provide Mechanical, Electrical, Plumbing and Fire Protection (MEP/FP) Consulting Engineering Services for the development of the hotel space on the Real Estate (the "Contract").

5. The Contract was entered into by Architect and the work was performed by Claimant with the knowledge and consent of Owner and Lessees. Alternatively, the Owner and Lessees specifically authorized Architect and/or Architect's agents to enter into contracts for improvement of the Real Estate. Alternatively, the Owner and Lessees knowingly permitted Architect to enter into contracts for improvement of the Real Estate.

6. Throughout the course of performing the Contract, at the special insistence of the Architect and Owner, Claimant provided extra and additional work.

7. On May 20, 2011, Claimant last performed work required to be performed under the Contract.

8. Claimant previously recorded a Subcontractor's Notice and Claim for Mechanics Lien in the amount of Two Hundred Twenty-Six Thousand Six Hundred Fifty-Five and 24/100 Dollars (\$226,655.24), which document was recorded with The Cook County Recorder of Deeds on the 25th day of February, 2011 as Document No. 1105613055 (the "First Lien"). The lien claimed herein is for work that was performed subsequent to recording the First Lien, but prior to the date on which Claimant last performed work under the Contract.

9. As of the date hereof, there is due, unpaid and owing to Claimant, after allowing credits for payments by Architect, the balance of Sixty-Three Thousand Three Hundred Fifteen and 43/100 Dollars (\$63,315.43) for which, with interest, Claimant claims a lien on the Real Estate, the leasehold interest of Lessees in the Real Estate and on the monies or other consideration due or to become due from Owners to Architect under the Owner's contract with the Architect. This amount is for work done subsequent to the recording of the previous lien, and this lien is for work that is in addition to the

Wherefore, Claimant possessing the right by Illinois Statute to a Mechanic's Lien on and against the Real Estate, the leasehold interest of Lessees in the Real Estate, and on the monies or other consideration due or to become due from Owner to Architect, as hereinbefore described, files its Subcontractor's Claim for Mechanics Lien in the Office of the Recorder of Deeds of Cook County.
