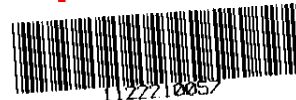

## SUPPLEMENTAL DECLARATION TO DECLARATION FOR DEVONSHIRE WOODS ESTATES

THIS SUPPLEMENTAL DECLARATION TO DECLARATION FOR  
DEVONSHIRE WOODS ESTATES (the "Amendment") is made and entered into this 14<sup>th</sup>  
day of July, 2011, by **OM&I HOFFMAN THREE, LLC**, a Delaware limited liability  
company ("**Declarant**").

### RECITALS

A. Declarant's predecessor-in-interest recorded that certain Declaration for  
Devonshire Woods Estates, dated July 25, 2008, and recorded in Cook County, Illinois, as  
Document Number 0820749003 (the "**Declaration**").

B. The Declaration subjects certain portions of the Development Area (as defined in  
the Declaration) to the terms and provisions of said Declaration.

C. Pursuant to Section 12.01 of the Declaration, Declarant wishes to add and subject  
an additional portion of the Development Area to the Declaration as "**Added Common Area**".  
Accordingly, the Declaration is hereby amended as set forth herein.

**NOW THEREFORE**, Declarant hereby declares as follows:

1. **Recitals; Defined Terms.** The foregoing recitals are hereby incorporated in this  
Amendment, with the same effect and as though fully set forth herein. Terms used in this  
Amendment as defined terms and not otherwise defined herein shall have the meanings assigned  
to them in the Declaration.

2. **Added Common Area.** From and after the date of this Amendment, the legal  
description for "Common Area" set forth in Part II of Exhibit B to the Declaration is hereby  
revised by inserting in its stead the legal description for "Common Area" set forth on Exhibit A  
attached hereto and made a part hereof. Accordingly, from and after the date of this

Amendment, all references to "Common Area" in the Declaration shall be deemed to mean the "Common Area" legally described on Exhibit A attached hereto and made a part hereof.

3. **Continuation of the Declaration.** This Amendment shall be deemed fully incorporated into the Declaration, and the Declaration (as expressly amended by this Amendment) is declared to be and shall continue in full force and effect in accordance with its terms.
