

Payment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. Br. rower shall pay when due the principal of, and interest on, the debt evidenced by the Note and any prepayment charges and late charges due under the Note. Borrower shall also pay funds for Escrow Items pursuant to Section 3. Payments due under the Note and this Security Instrument shall be made in U.S. currency. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. 9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument. 
