### DESCRIPTION OF PERSONAL PROPERTY SECURITY

All of Borrower's right, title and interest in, to and under the following:

- 1. - 2. All funds, account, deposits, instruments, documents, contract rights, general intangibles, notes, and chattel paper arising from or or virtue of any transaction related to the Land, the Improvements, or any of the personal property described in this Exhibit B.
