DEED IN TRUST

O'Shea, of Orland Park, as Co-Trustees under the provisions of a trust agreement dated the 3rd day of August, 2011, and known as the O'SHEA FAMILY REVOCABLE LIVING TRUST (hereing it is referred to as "said trustee" regardless of the number of trustees) and unto all and every successor or successors in trust under said trust agreement, the following described real estate in the County of Cook and State of Illinois, to wit:

And the said grantors hereby expressly waive and release any and all rights or benefit under and by virtue of any and all statutes of the State of Illir ois, providing for the exemption of homesteads from sale on execution or otherwise.
