2. Application of Payments or Proceeds. Except as otherwise described in this Section 2, all payments accepted and applied by Lender shall be applied in the following order of priority: (a) interest due under the Note; (b) principal due under the Note; (c) amounts due under Section 3. other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. Borrower and Lender providing for such termination or until termination is required by Applicable Law. Nothing in this Section 10 affects Borrower's obligation to pay interest at the rate provided in the Note.

"Environmental Condition" means a condition that can cause, contribute to, or otherwise trigger an Environmental Cleanup.
