- 4. Claimant completed its work under its contract co. 7/27/2011, which entailed Labor & Material-Interior Revovation & Remodeling to said premises.
- 5. There is due, unpaid and owing to Claimant, after allowing all credits, the principal sum of (\$20,354.00) which principal amount bears interest at the statutory rate of ten percent (10%) per annum, (as provided for by 770 ILCS 60/1) and costs and reasonable attorney feet (as provided for by 770 ILCS 60/17).
