SHORT FORM FOR ARTICLES OF AGREEMENT

THIS SHORT FORM OF ARTICLES OF AGREEMENT is dated <u>August 4, 2011</u> and is by and between **GUILLERIAD LOPEZ** and **DOLORES LOPEZ**, ("Sellers") **EUSTOLIA GAMBOA** ("Purchaser").
