MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated August 29, 2011, is made and executed between George A. Perez and Nitza T. Perez, husband and wife, whose address is 6025 South Kilbourn Avenue, Chicago, IL 60629 (referred to below as "Grantor") and Park Federal Savings Bank, whose address is 2740 West 55th Street, Chicago, IL 60632 (referred to below as "Lender").

MORTGAGE. Lender and Grantor have entered into a Mortgage dated June 8, 2009 (the "Mortgage") which has been recorded in Cook County, State of Illinois, as follows:

REAL PROPERTY DESCRIPTION. The Mortgage covers the following described real property located in Cook County, State of Illinois:

THE NORTH QUARTER OF LOT 8 IN BLOCK 7 IN BARTLETT'S 63RD STREET SUBDIVISION IN THE SOUTHWEST 1/4 OF SECTION 15, TOWNSHIP 38 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS

The Real Property or its address is commonly known as 6025 South Kilbourn Avenue, Chicago, IL 60629. The Real Property tax identification number is 19-15-313-044-0000.


MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

To amend interest rate from Five and One Eighth (5.125%) Percent per annum to Three and Five Eighths (3.625%) Percent per annum. To amend principal and interest payments from One Thousand Three Hundred Fifteen Dollars and 58/100 Cents (\$1,315.58) per month to One Thousand Two Hundred Four Dollars and 54/100 Cents (\$1,204.54) per month beginning September 1, 2011. It is agreed that the unpaid principal balance of said indebtedness at this date is One Hundred Forty Eight Thousand Nine Hundred Ten Dollars and 13/100 Cents (\$148,910.13). The term remains at 155 months to maturity. The maturity date remains at July 1, 2024. All other terms and conditions of the original Note and Mortgage remain the same.





It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
