PERMANENT EASEMENT AGREEMENT

THIS INDENTURE, made this 2/day of Av., 2011, by VINCENT EVERSON ("Owner"), for the benefit of the VILLAGE OF OLYMPIA FIELDS ("Village"), an Illinois municipal corporation, with its offices at 20040 Governors Highway, Olympia Fields, IL 60461

## AGREEMENT GRANTING PERMANENT EASEMENT

THIS EASEMENT AGREEMENT ("Agreement") is hereby entered into by and between the Village of Olympia Fields, Cook County, Illinois ("Village") and Vincent Everson ("Owner"):

#### RECITALS

- A. Owner is the owner of record of certain property legally described on Exhibit A, attached hereto and made a part hereof, with a common address of 20703 Cak Lane, Olympia Fields, Illinois (the "Subject Property").
  - B. The Subject Property is within the corporate limits of the Village.
- C. The Subject Property fronts Oak Lane. Oak Lane is not a dedicated right-of-way.

  Oak Lane has historically been created and maintained through private subdivision and platting as well as private maintenance by owners abutting Oak Lane.
  - D. Owner, along with other owners of property fronting Oak Lane, has requested that

the Village assume the maintenance responsibilities for Oak Lane. The Village is agreeable to assuming these maintenance responsibilities.

E. Based on the Village's examination of the various historic deeds and plats of record, the Village has determined that the most expedient way to accomplish the parties' mutual goal is by all of the owners along Oak Lane granting a permanent easement to the Village for purposes of improving and maintaining Oak Lane along with related storm sewer and sanitary sewer maintenance improvements.

NOW, THEREFORE, it is hereby agreed as follows:

**SECTION 1:** Incorporation of Recitals. The recitals set forth hereinabove are incorporated as if set forth fully herein.

### SECTION 2: Grant of Easement, Maintenance; Restoration of Easement Parcel.

- A. Owner hereby grants the Village permanent easement on, along and under the property described on **Exhibit B**, attached hereto and made a part hereof (the "Easement Parcel"), for purposes of maintaining, repairing and improving the Easement Parcel for street purposes. This Grant of Easement includes the installation of any storm sewer, sanitary sewer or drainage facilities necessary to maintain Oak Lane in a manner consistent with prevailing Village standards.
- B. The Village agrees that upon completion of any repair and maintenance activities along the Easement Parcel, the Easement Parcel will be restored to its original condition in accordance with generally accepted engineering standards.
- C. Owner acknowledges that Oak Lane will be incorporated into the Village's road network system as if Oak Lane were a fully dedicated public right-of-way. Owner further acknowledges that nothing in this Agreement is intended to guarantee any particular level of

maintenance of Oak Lane. Such determinations shall be made by the Village in a manner consistent with its overall property maintenance responsibilities and budget conditions.

**SECTION 3:** Recordation. This Agreement shall be recorded in the office of the Cook County Recorder of Deeds.
