THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ABOVE

- 1. Mortgagor shall promptly pay when due the principal and interest indebtedness evidenced by the Note and the late charges as provided in the Note.
- 2. Unless applicable law provides otherwise, all payments received by Mortgagee under the Note and this Mortgage shall be applied by Mortgagees first in payment of amounts payable to Mortgagee by Mortgagor to interest payable on the Note, and then to the principal on the Note.

- 3. Mortgagor shall perform all Mortgagor' obligations under any Mortgage, deed of trust or other security over this Mortgage, including Mortgagor' covenants to make payments when due.
- 4. Mortgagor shall (1) excluding the building(s) or structure(s) demolished by the Mortgagor pursuant to the Agreement for Demolition between Mortgagor and Mortgagee, promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinate to a lien hereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to the Mortgagee; (4) complete within a reasonable time any building or buildings now or at any time in process of erection, construction, alternation, repair or rehabilitation upon said premises; (5) comply with all requirements of law or municipal ordinances with respect to the premises except as required by law or municipal ordinance with out the prior consent of Mortgagee.
- 5. Mortgagor shall pay refore any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges, including but not limited to leases and ground reats, against the premises when due, and shall, upon written request, furnish to the Mortgagee duplicate receipts therefor. - (A) Any and all awards heretofore or hereafter made or to be made to the present and all subsequent owners of the premises, by any governmental or other lawful authority for taking, by condemnation or eminent domain, the whole or any part of the premises or any improvement located thereon or any tenements, easements therein or appurtenances thereto (including any award from the United States Government at any time after the allowance of the claim therefor, the ascertzinment of the amount thereof and the issuance of the warrant for payment thereof), are hereby assigned by Mortgagor to Mortgagee, which award Mortgagee is hereby authorized to collect and receive from the condemnation authorities, and Mortgagee is hereby authorized to give appropriate receipts and acquittances therefor, and Mortgagee may use or apply the proceeds of such excel or awards, at its option, as follows: (a) as a credit upon any of the indebtedness secured kereby; or (b) deliver the same to the Mortgagor. Mortgagor covenant and agree that Mortgagor will give Mortgagee immediate notice of the actual and threatened commencement of any such proceedings under condemnation or eminent domain, affecting all or any part of the said premises (r ally tenements, easements therein or appurtenances thereto, including severance and consequential damage and change in grade of streets and will deliver to Mortgagee copies of any and all purity served in connection with any such proceedings. Mortgagor further covenant and agree to thake, execute, and deliver to Mortgagee, at any time or times upon request, free, clear, and discharged of any encumbrances of any kind whatsoever, any and all further assignments and/or instruments deemed necessary by Mortgagee for the purpose of validly and sufficiently assigning all awards and other compensation heretofore and hereafter to be made to Mortgagor for any taking, either permanent or temporary, under any such At Mortgagee's option, any such award may be applied to restoring the improvements, in which event the same shall be paid out it the same manner as is provided in Subsection (A) of this paragraph.
- (B) Application of Eminent Domain Proceeds. Notwithstanding any provision herein to the contrary and in particular Subsection (A) of this paragraph, in the event of any damage or taking as therein described by eminent domain of less than the entire mortgaged premises, it is hereby agreed the Mortgagee shall make available the proceeds of any avard received in connection with and in compensation for any such damage or taking for the purpose of rebuilding and restoring so much of the improvements within the premises affected thereby, subject to the following conditions: (a) that Mortgagor are not then in default under any of the terms, covenants and conditions hereof; (b) that all then existing leases affected in any way by such damage or taking shall continue in full force and effect without reduction or abatement of rental (except during the period of untenantability); (c) that Mortgagee shall first be given satisfactory proof that such improvements have been fully restored or that by the expenditure of such money will be fully restored, free and clear of all liens, except as to the lien of this Mortgage; (d) that in the event such award shall be insufficient to restore or rebuild the said improvements, Mortgagor shall deposit promptly with Mortgagee the amount of such deficiency, which, together with the award proceeds, shall be sufficient to restore and rebuild the said premises; (e) that in the event Mortgagor shall fail within a reasonable time, subject to delays

beyond their control, to restore or rebuild the said improvements, Mortgagee, its option, may restore or rebuild the said improvements for or on behalf of the Mortgagor and for such purpose may do all necessary acts including using said funds deposited by Mortgagor as aforesaid; (f) that the excess of said award not necessary for completing such restoration shall be applied as hereinbefore provided as a credit upon any portion, as selected by Mortgagee, of the indebtedness secured hereby. In the event any of the said conditions are not or cannot be satisfied, then the alternate disposition of such award as provided herein shall again become applicable. Under no circumstances shall Mortgagee become personally liable for the fulfillment of the terms, covenants and conditions contained in any of the said leases nor obligated to take any action to restore the said improvements.

10. Acknowledgment of Debt

Mortgagor shall furnish from time to time within fifteen (15) days after Mortgagee's request, a written statement, duly acknowledged, of the amount due upon this Mortgage and whether any alleged offsets or defenses exist against the indebtedness secured by this Mortgage.

- 11. In case of default thereia, Mortgagee may, but need not, make any payment or perform any act herein before required c? Mortgagor in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, comcromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sele or forfeiture affecting said premises or contest any tax or assessment, and, if any action is commenced, upon notice to Mortgagor, may make appearances, disburse such sums, including but not limited to reasonable attorney's fees, and take such action as is necessary to protect Mortgagee's interest. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including attorneys' fees, and any other moneys advanced by Mortuagee to protect the mortgaged premises and the lien hereof, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the highest rate now permitted by Illinois law. Inaction of Mortgagee shall never be considered as a waiver of any right accruing to the Mortgagee on account of any default her under on the part of the Mortgagor.
- 12. The Mortgagor making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.

Mortgagor shall pay each item of Mortgage herein mentioned, including but not limited to the indebtedness evidenced by the Note, both principal and interest, when due according to the terms hereof and of the Note. - (a) Discovery by the Mortgagee of any material misrepresentation or falsity in any representation, statement, affidavit, certificates, exhibit or instrument given or delivered by Mortgagor, to the Mortgagee in connection with the making of this Mortgage; or,
- (b) The bankruptcy, reorganization, dissolution of Mortgagor, exchange, disposition, refinancing, or sale under foreclosure of the property; or,
- (c) The acquisition in whole or in part, voluntary or involuntary, of title, the beneficial interest, or the equity of redemption in the property by any party other than Mortgagor except where such garafer is approved in writing by the Mortgagee and the transferee assumes the obligations of the Mortgage and the Mortgage Note and the conditions contained within both.
- (d) Any charge in the form of ownership of the subject property or any portion thereof or any change in partners in the partnership without prior written consent of Mortgagee; or,
- When the indebtedness hereby secured shall be due, whether by acceleration or 15. otherwise, Mortgagee shall have the right to foreclose the lien hereof. - 17. Upon or at any time the filing of a complaint to foreclose this Mortgage, the court in which such complaint is filed may appoint a receiver of said premises. Such appointment may

be made either before or after sale, without notice, without regard to the solvency or insolvency of Mortgagor at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not, and the Mortgagee may be appointed as such receiver. Such receive shall give power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit, and in case of sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Mortgagor, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said period. The Court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of: (1) The indebteuress secured hereby, or by any decree foreclosing this Mortgage, or any tax, special assessment or of the lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of a sale and deficiency.

- 18. No action for the enforcement of the lien or of any provision hereof shall be subject to any defense which would not be good and available to the party interposing same in action at law upon the note hereby secured.
- 19. The Mortgagee shall have the right to inspect or may cause the inspection of the premises at all reasonable times and access thereto shall be permitted for that purpose.
- 20. If the payment of said indebtedness or any part thereof be extended or varied or if any part of the security be released, all persons now or at any time hereafter liable therefor, or interested in said premises, shall be held to assent to such extension, variation or release, and their liability and the lien and all provisions hereof shall continue in full force, the right of recourse against all such persons being expressly reserved by the Mortgagee, notwithstanding such extension, variation or release.
- 21. Mortgagee shall release this Mortgage and lien thereof by proper instrument upon payment and discharge of all indebtedness secured hereby and payment of a reasonable fee to Mortgagee for the execution of such release.
- 22. This Mortgage and all provisions hereof, shall extend to and be binding upon Mortgagor and all persons claiming under or through Mortgagor and the word "Mortgagor" when used herein shall include all such persons and all persons liable for the payment of the indebtedness of any part thereof, whether or not such persons shall have executed the Mortgage Note or this Mortgage. The word "Mortgagee" when used herein shall include the successors and assigns of the Mortgagee named herein and the holder or holders, from time to time, of the note secured hereby.
- 23. The state and local laws applicable to this Mortgage shall be the laws of the jurisdiction in which the property is located. The foregoing sentence shall not limit the applicability of Federal law to this Mortgage. In the event that any provision or clause of this Mortgage or of the Note conflicts with applicable law, such conflict shall not affect other provisions of this

Mortgage or of the Note which can be given effect without the conflicting provisions, and to this end the provisions of this Mortgage and the Note are declared to be severable.

- 24. Upon Mortgagor' breach of any covenant or agreement of Mortgagor in this Mortgage, including the covenants to pay when due any sums secured by this Mortgage, Mortgagee prior to the acceleration shall give notice to Mortgagor specifying: (1) the breach; (2) the action required to cure such breach; (3) a date, not less than 10 days from the date the notice is mailed to Mortgagor, by which such breach must be cured; and (4) that failure to cure such breach on or before the date specified in the notice may result in acceleration of the sums secured by this Mortgage foreclosure by judicial proceeding, and sale of property. The notice shall further inform Mortgagor of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the nonexistence of a default or any other defense of Mortgagor to acceleration and foreclosure. If the breach is not cured on or before the date specified in the notice, Mortgagee, at Mortgagee's option, may declare all of the sums secured by this Mortgage to be immediately due and payable without further demand and may foreclose this Mortgage by judicial proceeding. Mortgagee shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable attorney's fees and costs of documentary evidence, abstracts and title reports.
- Mortgagor' breach, Mortgagor shall have the right to have any proceedings begun by Mortgagor to enforce this Mortgage discontinued at any time prior to entry of a judgment enforcing this Mortgage if: (a) Mortgagor pay Mortgagee all sums which would be then due under this Mortgage and Note had no acceleration occurred, (b) Mortgagor cure all breaches of any other covenants or agreements of Mortgagor contained in this Mortgage; (c) Mortgagor pay all reasonable expenses incurred by Mortgagee in enforcing the covenants and agreements of Mortgagor contained in this Mortgage, and in enforcing Mortgagee's remedies as provided in paragraph 11 hereof, including, but not limited to, reasonable artorney's fees; and (d) Mortgagor take such action as Mortgagor may reasonably require to assure that the lien of this Mortgage, Mortgagee's interest in the property and Mortgagor' obligation to pay the sums secured by this Mortgagor' obligation to pay the sums secured by this Mortgagor' obligation to pay the sums secured by this Mortgage shall continue unimpaired. All rents collected by the receiver shall be applied first to payment of the costs of management of the property and collection of rents, including, but not limited to, receiver's fees, premiums on receiver's bonds and reasonable attorneys' fees, and then to the sums secured by this Mortgage. The receiver shall be liable to account only for those rents actually received.
