THEREFORE, in consideration the sum of \$10.00 and other good and valuable consideration, BORROWER and LENDER agree as follows;

The parties agree that the only changes effectuated by this modification agreement are the interest rate and the date of maturity. All other terms and conditions remain in full force and effect.

That as of the date of this Agreement, the unpaid principal balance of indebtedness is \$152,983.69, all of which borrower promises to pay with interest at 5.00% per annum until paid in full and that the same shall be payable in monthly installments of \$897.35 beginning on the 1st day of November, 2011, to be applied as provided in the Note and Mortgage identified above, plus a sum estimated to be sufficient to discharge tax and insurance obligations (which estimated sum may be adjusted as necessary). Such monthly installments shall continue until entire indebtedness evidenced by the Note if fully paid, except that any remaining indebtedness, if not sooner paid, shall be due and payable on

All the remaining terms of the Note and Mortgage shall remain in full force and effect and the same are hereby reaffirmed and incorporated
