THIS MEMORANDUM OF AGREEMENT is made this 20 day of october, 2011, by and between OPEN ARMS UNITED WORSHIP CENTER, f/k/a Faith Tabernacle of Chicago Inc., an Illinois Religious Corporation ("Open Arms") and HALSTED GRACE VENTURES LLC, an Illinois limited liability company ("Halsted").
