Pursuant to Title 18, United States Code, Section 3613(c), a criminal fine or an order to pay restitution imposed pursuant to the provisions of Subchapter C of Chapter 227, Subchapter B of Chapter 229, and/or Chapter 212, Title 18, United States Code constitutes a lien in favor of the United States upon all property belonging to the person fined or ordered to pay restitution. This lien in favor of the United States against the property of the defendant may or may not attach to the property identified below as being the defendant's address depending on whether or not the defendant has any ownership interest in such property.
