No later than four court days before the hearing date, the moving party shall supply the court with courtesy copies of the motion, all briefs filed in support or opposition to the motion, any reply brief, any other relevant pleadings from the case, and copies of any federal or non-Illinois state cases cited in the briefs. The court directs the parties' attention to the general standing orders of the Mortgage Foreclosure/Mechanics Lien Section which govern all filings in this case. Motions or briefs may be stricken for violation of this order.
