TO HAVE AND TO HOLD the same unto said party of the second part, forever.

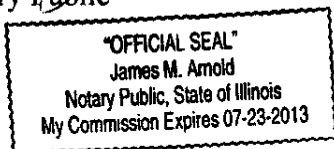
